Admission Requirements

In order to process your application, we will require the following documents:

1. Completed and signed application form including Declaration of Principles.
2. School reports for previous two years.
3. Proof of temporary residence in Sweden; for example, a letter from your company or organization
4. Vaccination report
5. Documentation from current school:
 - Report cards
 - Contact details of the mentor
 - Other necessary documentation (e.g. special needs, allergies)

Criteria for admission

Students pursuing admission at International School of Boden need to meet one of the criteria below in order to be granted admission. Choose which criteria your child meets by checking one of the boxes below.

Student in an international family moving to Boden or the region from abroad and staying for a limited time.

Student in a family moving to Boden or the region who have attended an International School abroad for a major part of their education and therefore have a reason to complete his/her education in an International School.

Having attended an International Preschool is not a given condition to be enrolled.

Students living in Boden and fulfilling one of the criteria above will be prioritized over students living in another city in the region when granting admissions.
